

The pace of activity picked up a bit this week with five deals announced. Coinbase acquired the SEC-registered investment advisor sub of One River, One River Digital Asset Management. ORDAM will form the foundation of Coinbase Asset Management with a focus on institutional clients. The two companies share a history of close partnership. In another financial services deal, SBI Japan bought crypto lender and blockchain research provider HashHub.

In a gaming deal, The Sandbox Germany acquired Sviper. The Sandbox is a blockchain gaming company which is owned by Animoca Brands. Sviper is a Hamburg-based game development studio. The deal strengthens Sandbox's presence in Germany.

In one of two infrastructure-related deals, \$35B market cap company Rockwell Automation, the world's largest company dedicated to industrial automation and digital transformation, announced that it acquired Knowledge Lens. Knowledge Lens is a digital technology consulting company, that provides industrial AI, sustainability, and digital transformation solutions to companies. They also provide blockchain-powered solutions, including provenance tracking & secure database management. This is the kind of deal we refer to as a bridge transaction or one in which a non-crypto-native firm acquires crypto capabilities.

Finally, in a second and modest infrastructure deal, DComm Infrastructure, a subsidiary of Web3-focused DComm Ventures, bought DC Two's modular data center business.
